All which said next Court to with the sixteenth day of March and Doth: One thousand Seven hundred and twenty four Came againe as well the afd Jeffrey as the afd Jeff by their attorney, afd and thereupon the Said Jeff by his Said attorney prayed further Leave to Imparte herunto untill the Next Court and he hath it and the same day is given to the afd Jeff also -----

All which said next Court came to with the fifteenth day of June and Doth: One thousand Seven hundred and twenty five Came againe as well the afd Jeffrey flowers as the afd Thomas Brien by their attorney, afd and thereupon the Said Thomas by his Said attorney as before defend: the force and Injury when he and says that he did not assume upon himselfe in Manner and form as the afd Jeffrey above against him hath Complained and of this he puts himselfe upon the Country &c. At the yllt Likewise -----

Whereupon the afd Thomas Brien by his attorney afd Relinquisheth his Verification afd by him above pleaded, and says that he is not Informed by the same Thomas Brien his Oyant of any answer for the same Tho: to the afd Jeffrey, the plea afd and Nothing els thereof says by which the same Jeffrey flowers Remains against the afd Jeffrey flower <sup>his</sup> damages by Occasion of the Nonperformance of the promise and assumption afd ought to Recover, but because it is not known to his Lordship's Justice <sup>here</sup> what damages the afd Jeffrey flower hath Sustained as well by Occasion of the Nonperformance of the promise and assumption afd as for his costs and Charges by him about his Suite in that part Expended - therefore Com- mand is to the Sher: that by the Oath of honest & Lawfull men of his Bailiwick or County he diligently Inquire what damages the afd Jeffrey flower as well by Occasion of the Non performance of the promise & assumption afd as for his costs and Charges by him about his <sup>Suite</sup> Sustained and the Inquisition which thereof he should take to his Lordship's Justice at dividing Creek the third Tuesday of August Next under his Seal, and the Seals of those by whose Oath he make the same, he send with this writ therof to him directed &c. and the same day is given to the afd Jeffrey there also &c. -----

All which said third Tuesday of August to with the seveneenth day of the same Month and Doth: One thousand Seven hundred and twenty five before his Lordship's Justice at dividing Creek Cometh the afd Jeffrey flower by his attorney, afd and the Sher: Returned a certain Inquisition before him taken at the Wading place at the head of Back Creek in Somerset County in Maryland, on the tenth day of August One thousand Seven hundred and twenty five, by which it appears that the afd Jeffrey flower Sustained damages by Occasion of the Non performance of the promise and assumption afd, besides his costs and Charges by him about his Suite in that part Expended to the value of One hundred Seven Shillings and two pence three farthings Curr. money of Virginia, of the value of Twenty three pounds Nine Shillings and the Ten pence Curr. money of Maryland and for those costs and Charges to One pound of tobacco ----- Therefore it is Considered by the Court here (the)
