Therefore it is considered by the Justice here the sixteenth day of Novemb. and Done One thousand seven hundred and twenty five and that the said Thomas Timons have Exponen ag^t the said ~~John~~ John Dayton of the Judgmt. and as well for the Sum of five hundred pounds of tobacco and fifteen Bushels of Indian Corn certain Damages as also the Sum of two hundred and forty pounds of tobacco Certs of Suite in the Judgmt. and Specified as also the Sum of Two hundred (257) and fifty Seven - - - pounds of tobacco by the Court here adjudged unto him for his Costs & Damages Sustained by Omission of Delay of Execution of the Judgment and &c
