pounds current money and three hundred and thirty one pounds of tobacco and when you have
the same attached or any part thereof the same in your custody safe keep so that you have the same
before the Justices of Our County Court to be held at Dividing Creek in Somerset County afo
the third Tuesday of November next thence there to be condemned according to act of assembly
to be for the use of a certain Mary Martin Esq: Last will & testament of Robert Martin deceased
unless y^e Said Michael Holland by himself or his attorney shall appear and answer unto y^e Said
Mary Martin in geale that he tender unto her thirty two pounds current money which from
her he unjustly Detained & according to Law that by good & lawfull men of your Bailiwick
you make known unto y^e person or persons in whose hands you make y^e same attachment that
he she or they be & appear before y^e Justices of Our Said County Court to be held as afo to shew
cause if any she or they have why y^e same Goods or Chattels Rights or Credits so attached in
his her or their hands Ought not to be condemned & executed Thereof shall be made
according to y^e form of act of assembly in such case made & Provided if to him her or them
it shall seem meet & how you shall execute this writt that you make known unto our Said
Justices at y^e same day & Place afo & have you then & ther this writt witness Samuel
Hopkins Gent: Chief Justice of our Said Court the 1st day of August in the 10th year of Our
Dominion & anno Domⁱ 1725 —
