Whereupon the said Thomas Gillis Garnishe as aforesaid altho' solemnly called to Show cause &
comes not but makes default nor does any other person appear for him to Show cause to the
Contrary &c. Whereupon the aforesaid Mary Martin by her attorney aforesaid prays that Nine
hundred and Twenty One pounds of Tobacco part of the Sum aforesaid attached as of the Rights
and Credits of the said Jonathan Raymond may be condemned in the hands of the said Thomas
Gillis towards Satisfying unto the said Mary Martin as well her Damages & Costs Recovered
against the said Jonathan Raymond as also the Costs accruing upon the writ of Attachment aforesaid

Therefore it is considered by the Justices here the Sixteenth day of March and
Dond. One thousand Seven hundred and twenty five aforesaid that the said Sum of Nine hundred and
Twenty One pounds of Tobacco part of the Sum so as aforesaid attached be condemned in the hands of
the said Thomas Gillis as of the Rights and Credits of the said Jonathan Raymond towards Satis-
fying unto the said Mary Martin & her Executors as aforesaid well ^{her} Certain Damages and Costs recovered
against the said Jonathan Raymond as also all Costs accruing upon the writ of Attachment aforesaid
and that the said Mary Martin have her Execution thereof against the said Thomas Gillis aforesaid
ing to act of assembly &c

If The Same Memorandum the 8th by Lewis Gale her attorney sued out his Lordships writ
George Hutchins of Sirefauis against the death the tenor whereof follows in these words vizt.
Somerset sh: Charles absolute Lord and proprietary of the province
of Maryland and Avalon Lord Baron of Baltimore &c. To the Shew. of Somerset County greeting
whereas a certain Robert Martin lately in our County Court of Somerset to witt on the Eighteenth
day of June in y^e Eight year of our Dominion &c. anno Dond. One thousand Seven hundred and
twenty three before y^e worthy full Charles Ballard Gent & his associates then Justices of
our said Court (at Dividing Creek) & by Consideration of our said Court recovered against
a certain George Hutchins of Slegny Parish in Somerset County Planter as well the Sum of
One thousand Six hundred & fifty Six pounds of Tobacco Certain Damages as also the Sum of
two hundred & forty two pounds of Tobacco which to y^e said Robert Martin in our said Court were
adjudged for his Costs & Charges by him about his Suite Laid out & Expended whereof he is
Convicted as by y^e Records & process hereof in our said Court before our Justices at Dividing Creek
now remaining manifestly appeareth, Nevertheless Execution of the Judgment aforesaid yett
remains to be done by y^e said Robert Martin since dead as by the Insinuation of Mary
Martin Elect &c. of y^e Last will & testament of y^e said Robert Martin we have seen
& because we will that those things which in our said Court are rightly done should be brought
to a due Execution - We Command you that by good & Lawfull men of your bailiwick you
