A copy of the foregoing declaration was made and sent with the writ in the year —
At which said third Tuesday of November to the Sixteenth day of the same month and anno Domini One
thousand and seven hundred and twenty five being the day of the return of the said Writ came to the
said William Edmund by his attorney and the Sheriff of Somerset County and to whom the before-
going Writ was directed Likewise came and made her return thereof to the Court here endorsed
in these words following viz — *legi corpus declaration delivered in time of trial*
