Hundred and twenty six pounds of tobacco to the said Joseph he hath not paid or to him for the same in any wise contented altho' the same to do the said Alexander by the said Joseph on the first day of August and Dated One thousand Seven hundred and twenty five and often after ward, at the County aforesaid within the Jurisdiction aforesaid he was theremore registered but the same to him to pay or in any wise to content hath refused and still doth refuse and deny whereupon the said Joseph saith he is worse and hath damage to the value of Eight hundred and fifty two pounds of tobacco and whereupon he brings his Suite &c. It is ordered whereupon the said Alexander Hudson being called appears and therupon the said Alexander Hudson at the prayer of the plf attorney aforesaid adjudged to give special bail to the action aforesaid. Whereupon a certain Thomas Preacher of Somerset County planter present here in Court undertaken for the said Alexander Hudson that if in case the said Joseph Macler ter shall recover Judgment in the plea aforesaid against the said Alexander Hudson or that the said Alexander Hudson shall be herein found guilty then he the said Alexander Hudson shall pay the Condemnation of the Court hereupon or lade his body to the custody of the Sheriff of Somerset County in Satisfaction thereof or that he the said Thomas Preacher will do it for him whereupon the said Alexander Hudson in his own proper person cometh and defendeth the same and injury when he and sayth that he cannot gainay the plf his action aforesaid so as afores against him brought nor can he say but that the said plf ought to recover his damages by occasion of the premises aforesaid One hundred and twenty six pounds of tobacco and costs of Suite against him which the said plf doth not gainay &

Wherefore it is considered by the Justices here the Sixteenth day of November and dmd. One thousand Seven hundred and twenty five that the aforesaid Joseph Macler recover against the aforesaid Alexander Hudson his damages by occasion of the premises aforesaid for the sum of One hundred and twenty six pounds of tobacco as also the sum of Three hundred and twenty seven — pounds of tobacco by the Court here adjudged unto him for his costs and charges by him about his Suite in this behalf laid out & expended & doth remit Mery &c.
