but that the Writing Obligatory agt is his act and deed and that the debt therein Mentioned is yett due and  
unsatisfied wherefore the Said Jft. prays Judgment for his debt agt and his Costs and Damages Sustained by  
Reason of the detaining of the Same debt to him to be adjudged &

Therefore it is considered by the Justice here the Sixteenth day of Novemb. 1725  
One thousand Seven hundred & twenty five agt that the agt Joseph M<sup>r</sup> Carter Recover against the agt John Hud-  
son Ind. as well the Sum of Twenty four thousand two hundred pounds of tobacco his debt agt as also the  
Sum of twelve hundred and twenty three -- pounds of tobacco for his Costs and Damages Sustained by Reason  
of the detaining of the Same debt to the Same Joseph M<sup>r</sup> Carter by the fault here adjudged  
and the agt doth in Merry & And whereupon the agt Joseph M<sup>r</sup> Carter by his attorney herein Com-  
eth freely Release the agt John Hudson Ind. from the Sum of twenty four thousand two hundred pounds of tobacco  
the debt agt, therefore the Same John Hudson, of the Same debt be thereof acquitted &

Whereas the Said Mary Martin having sued and Impleaded a certain Certain  
Robert Martin --- }  
John Bredy --- }  
Mankowee for the Sum of Eight hundred and fifty One pounds of tobacco debt, and  
Like wise J<sup>r</sup> Bredy for the Sum of four hundred and Ninety pounds of tobacco  
debt & Whereupon the agt John Bredy in his proper person Cometh and defendeth the  
force and Injury when & said that he cannot give say but that the said Mary Martin agt as agt  
ought to Recover against him as well the Sum of Eight hundred and fifty One pounds of tobacco the Debt due  
from the agt Mankowee as the Sum of four hundred and Ninety pounds of tobacco his own Debt, wherefore the  
Said Mary Martin prays Judgment for the Debt agt and her Costs and Damages Sustained by Reason of the  
detaining of the Same debt to her to be adjudged &

Therefore it is considered by the Justice here the Sixteenth day of Novemb. 1725  
One thousand Seven hundred and twenty five that the agt Mary Martin agt as agt Recovered against the agt  
John Bredy as well the Sum of Eight hundred and fifty One pounds of tobacco the debt of the agt Robert  
Mankowee, as four hundred and Ninety pounds of tobacco his own proper Debt which in the whole amount  
to thirteen hundred and forty One pounds of tobacco, as also the Sum of four hundred and Eighteen pounds of  
tobacco for her Costs and Damages Sustained by Reason of the detaining of the Same debt to the  
Same Mary Martin agt as agt after a fault by the fault here adjudged & the agt doth in Merry &

This being an action of Debt for Eight thousand pounds of tobacco &  
wherein the Sher. of Somerset County to whom the writ in the Same action was  
Directed Cometh and maketh Return thereof to the Court here Endorsed w<sup>th</sup> Copy Copy of Return. And the
