 himself unto the afd Robert fifteen Hundred pounds of Tobacco when afterwards
 he should be here to requested Never the less the afd Lazarus although he furnished
 and Seventy Bonds pounds of Tobacco part of the afd fifteen hundred pounds of Tobo
 to the same Robert Hall rendered yet he the Sum of Nine hundred and thirty pounds
 of Tobacco the residue of the Sum of fifteen hundred pounds of Tobacco to the same
 Robert Hall not rendered (although often there to required) but the same
 Lazarus the said Sum of Nine hundred and thirty pounds of Tobacco the residue
 as afd the same Robert further to render hath altogether done & still doth
 Done whereby the same Robert says he is worse challed damage to the Value

And the said Lazarus Maddug by Francis Allen his attorney Cometh and Defendeth his
 fame and Injury when to and prayeth Leave to Injare here unto until the next Court
 and he hath it of the same day in his Bill unto the afd Robert Maromb also —
 At which said Next Court to wit the sixteenth day of March and Dom One thousand Seven
 Hundred and Twenty four came again as with the afd Robert Maromb as the afd
 Lazarus Maddug by their attorney afd, and the same attorney saith, that he is not Inframed, by the
 same Lazarus Maddug (his Agent) of any answer, by the same Lazarus, to the afd Robert Maromb in
 the plea afd to be given, and nothing Else thereof saith whereby the same Robert Remains against the afd
 Lazarus thereof undefeinded & — Therefore it is considered by the Court here the same day and year
 last mentioned that the afd Robert Maromb recover against the afd Lazarus Maddug as well the Sum of Nine hundred
 thirty pounds of Tobacco his Debt afd as also the Sum of Two hundred and fifty Nine . pounds of Tobacco by the Court here
 ad judged unto him for his Costs and damages Sustained by reason of the Detaining of the same Debt and the afd
 Lazarus Maddug in Mersey &c
