thousand pounds of tobacco his debt ad, and his damages by reason of the detaining of the same debt to
255 two hundred and fifty five --- pounds of tobacco, to the same John by the Court here of his ad
adjudged and the ad Williams in Meru

adjudged to give speciall Bail to the action ad thereupon a certain Merrick Ellis of Somerset County hath
present herein Court in his proper person undertakes for the said Mary Buce, that if in case the ad George
Cook shall recover Judgment in the plea ad against the ad Mary Buce, or that the said Mary Buce shall
be therein Convict that then she the ad Mary Buce shall pay the Exemnation of the Court thereupon or suffer
her body to the Custody of the Sherif of Somerset County in satisfaction thereof or that he the said Merrick
Ellis will do it for her,

Whereupon the ad Mary Buce by George Dashed her attorney prays that the said
George Cook may give security for Costs in case nonvnde be obtained against him in the plea ad which is by the
Court granted, whereupon Seri Gale of Somerset County hath present herein Court undertakes for the said Geo. Cook
that in case he be nonvnded in the plea ad or otherwise legally for that then the said Geo. Cook shall pay the Exemna-
