Memorandum the 25th by Lewis Galahis attorney sheweth out his Lordship's writ of attachment against Mary Esome adu'd of Benj^d Esome - - - - - Somerset sh^{rs} Charles absolute Lord and proprietor of the province of Maryland &c.

Command you if you attach any the goods Chattels rights or credits of Mary Esome adu'd of all singular the goods Chattels rights & credits of Benj^d Esome late of Somerset County & latter said: if they shall be found in your Bailwick to the value of twenty p^{cs} Curr^t Money & Eight hundred p^{cs} of Tob^o: when you have the same so attached or any part thereof the same in your Custody safe Keep so if you have them before the Justice of our City Court to be held at Dividing Creek the third Tuesday of June next then & there to be condemned according to act of Assembly to & for the use of a certain Ind. Esome unless the said Mary Esome adu'd as afo^{re} by herself or her atty shall appear and answer unto the said Ind. Esome in a plea of trespass upon the Case & according to Law & that by good & Lawfull men of your Bailwick you Make known unto the person or persons in whose hands you Make the same attachment: that he she or they be & appear before the Justices of our City Co^{ty}: to be held as afo^{re} to shew Cause if any he she or they have why the same goods Chattels rights or credits so attached in his her or their hands Ought not to be condemned & Execution thereof had & Made according to the form of the act of Assembly in such Case Made & provided if to him her or them it shall seem Meet & how you shall Execute this writt that you Make known unto our P^{re} Justices at the day & Place afo^{re} & have you then & there this writt Witness I said Joseph Gent^l Chief Justice of our City Co^{ty}: the twenty first day of March in the thirteenth year of our Dominion &c.

At which said third Tuesday of June to wit the Eighteenth day of the same month being the day of the Return of the said writt and Dowd One thousand seven hundred and twenty eight being the day of the Return of the said writt Cometh the said John Esome by his attorney afo^{re} and the Sheriff of Somerset County to whom the foregoing writt was directed Likewise Cometh and maketh Return thereof to the Court here said: in these words following viz^t. By virtue of the within writt to me directed I have attached the rights & credits of the within named Mary Esome adu'd of Benj^d Esome dec^d: in the hands of Robert Collier Ind. Hogkins Henry Dashiell Ind. Richardson & David Johnson to the value of twenty p^{cs} Curr^t money & Eight hundred p^{cs} of Tob^o: & have severally summoned the s^d parties to be and appear before the Justices within named at the ^{time and} Place within Mentioned to shew Cause & if any they shew why &c.
