Therefore it is Considered by the Justices here the Eighteenth day of June and found One thousand Seven hundred and twenty Eight that the said Sum of thirteen pounds fifteen shillings part of the Sum so attached and Confessed, be condemned in the hands of the said John Richardson as of the Rights and Credits of the said Mary Some *ad* *ad* Benjamin Some *ad* towards Satisfying unto the *ad* John Some, as well the Sum of twenty pounds Curr. money and Eight hundred pounds of Tobacco as also the Costs accruing upon the writt of attachment *ad* and that the *ad* John Some have thereof his Execution against the *ad* John Richardson according to act of Assembly &c.

Therefore it is Considered by the Justices here the same day and Year last mentioned that the said Sum of one pound Eighteen shillings one penny part of the Sum so attached and Confessed be condemned in the hands of the said *ad* Hopkins as of the Rights & Credits of the said Mary Some *ad* *ad* Benjamin Some *ad* towards Satisfying unto the *ad* John Some as well the Sum of twenty pounds Curr. Money and Eight hundred pounds of Tob. as also the Costs accruing upon the writt of attachment *ad* and that the *ad* John Some have thereof his Execution against the *ad* John Hopkins according to act of Assembly &c.
