first Boundary of the Land called Burgatory was set at the point called the Eagles Nest point and
as ^{Geo} Whittington run the Length of the Land called graves End this Deponant crossed the Chain
above the Land called Burgatory two or three times to try the Breadth above it Being the Land then
taken up and further saith not

at which place was set a Cedar Post -

His Lordship - } We of the grand jury for the body of Somerset County do present Elij^o Ackman
Elij^o Ackman - } of said County for bearing off a bastard Child in the said County Information given
by M^{rs} Ellis, being born about the first of December 1727. Adam Heath foreman -

Thereupon Command was given to the Sher^o of Somerset County that he should take the said Elij^o
Ackman if he so to answer &c.

And afterwards in the same Court came the afo^d Elij^o Ackman and
being by the Sher^o sett to the bar is thereupon Instantly demanded how she would acquit herself of
the premises afo^d, says that of the premises afo^d she is guilty thereof, and prays that she may
be admitted to make fine to the said Lord proprietary for the fact afo^d.

Wherefore it is considered by the Justice here that the afo^d Elij^o Ackman be fined to her
Lordship for the fact afo^d ^{that she be taken &c.} toward the defraying of the County Charge
thereupon the said Elij^o Ackman is discharged, and ordered to return into her Masters Service
and that her said Master Merriuk Ellis Return her to the County Court or the Sher^o of the County for
the time being, to be bound to said County of Somerset at the fees due unto the several officers
by reason of the premises afo^d.

Whereupon at the prayer of the afo^d Merriuk Ellis the afo^d
Elij^o Ackman is adjudged to serve him at the Expiration of her Servitude, six full Months
which is adjudged by the Court as full Satisfaction for all trouble Charges and Loss of time in
her Serving in &c.

Ann Goller Executrix of Thomas Goller and Elij^o Danston Sec^o & Ind. Executrix of Ann Danston being
summed to Court to give Security for the balance of their Estates, are discharged by reason all
the Estate is given them by will of the dec^d &c.
