The Condition of the above Recognizance is such that if the above bound Isaac Williams do and shall well and truly learn the asd James Daughety during his servitude asd the trade of a cooper and to lead well in the bible, and find for his said Apprentice sufficient meat drink washing Lodging and Cloathing mete for such an apprentice to have and wear during his servitude asd then the above Recognizance to be void.
