

Dennis folio by their attorney, and the same attorney of the said Dennis says that he is not informed by the same Dennis his agent of any answer, for the same Dennis to the ap Henry in the plea ap to be given and nothing else therof says by which the same Henry Remanick against the ap Dennis therof understood, Wherefore the same Henry his damages by occasion of the premises against the ap Dennis ought to recover, but because it is not known what damages the ap Henry hath sustained by occasion of the premises Command is to the Just of Somerset County, that by the oath of honest and Lawfull men of his Bailiwick or County he diligently Enquire what damage the ap Henry hath sustained as well by occasion of the premises ap as for his costs and Charges by him about his suite in that part Expended, and the Inquisition which therof he takes, to his Lordship Justice of the County Court of Somerset to be hold at dividing Bench the third Tuesday of November then next under his Seal and the Seal of them by whose oath he takes the same Inquisition, he send together with the said writ to him therof directed and the same day is given to the ap ~~left~~ here also - At which said third Tuesday of November to wit the Nineteenth day of the same month and Year One thousand seven hundred and twenty eight before his Lordship Justice of the Peace for Somerset County at dividing Bench, Cometh the ap Henry Schofield by his attorney and the Just behind a certain Inquisition before him taken at the Court house in the County ap the twelfth day of November and year ap by which it appears that the ap Henry Schofield hath sustained damage by occasion of the premises besides his costs and Charges by him about his suit in that part Expended to, forty shillings current money, and for these costs and Charges to two pounds of tobacco.

Therefore it is considered that the ap Henry Schofield Recover against the ap Dennis folio forty shillings current money and two pounds of tobacco his damages ap as by the Inquisition ap appears as also One thousand and thirty seven pounds of tobacco for his costs and Charges ap, to the ap Henry by the Justice of his assent of Increase adjudged which certain damage in the whole do amount to forty shillings current money and One thousand & thirty nine pounds of tobacco to the ap Dennis in money.

And whereupon the same Adam by Lewis Gale his attorney Enjoins that whereas the ap Christopher in his life time the tenth day of May One thousand seven hundred and twenty five, at Somerset County ap within the Jurisdiction of this Court was indebted unto the same Adam in the sum of twenty eight pounds One shilling & seven pence current money as by amount herewith in Court produced may appear, and so therof being indebted, the said Christopher Dashiell in his life time afterwards vizt. the same day and year ap at the County ap within the ap Jurisdiction in consideration upon himselfe assumed and to the same Adam then and there faithfully promised that when afterwards he should be thereto required he the ap sum of twenty eight pounds One shilling and seven pence current money to the same Adam he would well and faithfully Content and pay, Nevertheless the ap Christopher in his life time and the ap Elizabeth since the death of the said Christopher the promise and assumption ap of the ap Christopher in his life time so as ap made little regarding and blotting and fraudulently Intending the same Adam in this part to defraud & deceive neither the ap Christopher in his life time, nor the ap Elizabeth since the death of the ap Christopher, the ap sum of twenty eight pounds One shilling and seven pence hath not paid nor him for it in any wise Contented altho. the same Christopher in his life time afterwards (to wit) the tenth day of June and Dow. One thousand seven hundred and twenty six and the ap Elizabeth since the death of the said Christopher the tenth day of November and Dow. One thousand seven hundred and twenty seven at Somerset County ap within the ap Jurisdiction.
