 Costs and Charges, by him about his suite in that part Expended, to Six pound seven Shillings &
 two pence one farthing Cur^t money of Maryland, and because the sd Archibald this not denies, but
 the same allegation in Every word Con^d fesseth, prays Judgment and his Damages above Con^d fessed
