The Condition of the above Obligation is Such that Whereas the Sherrifs have transmitted unto this Court the account of the Estate of Mercy fountain decd. wherein it is found that there is Balance due to the abovesaid Orphans the sum of fifty nine pounds twelve Shillings & two pence if there: for the abovesaid Mary fountain, W^m. Handy or Solomon Colebourn or any or Either of them or any or Either of their heirs & adm^r. do and shall well and truly pay or cause to be paid unto the said Orphans the sd Sum of fifty nine pounds twelve Shillings and two Pence Curr. money in Equal parts or portions when they shall attain to full age according to act of assembly in such case provided and the will of said decd.
