Ordered by the Court that Thomas Langfield pay unto Robert Wallton Sixty pounds of tob^o being due unto him for his attendance Two days as Evidence on behalfe of the said Tho^s. Langfield against Lth Henderson he haveing made oath to the same &c.

Ordered by the Court that Thomas Fletcher pay unto Daniel Wharton & John Bewin Ninety pounds of tobacco each being due unto them for their attendance three days each as Evidence on behalfe of his Lordship the Lord Proprietary against Thomas Fletcher they haveing made oath to the same &c.

Mr. Thomas Darshell - Somersetth. Charles absolute Lord and proprietor of the province of Maryland and Grandst. & Anthony West } as above Lord Baron of Baltimore &c. To the Sheriff of Somerset County greeting &c.
Esq^r. of H^h. West - } you that of the goods and Chattells which were of Catherine West dec^d. in the hands of

Randall and Anthony West. both of Somerset County Plaintiffs Esq^r. of the testant and last will of the afo^r Catherine West of the County of Somerset and province of Maryland &c. & in like being in your hands you make as well a certain Debt of ten thousand Seven hundred & Ninety four pounds of tob^o which Thomas Darshell in our Court before our Juries at deciding first recovered against them on the first day of march one thousand Seven hundred and twenty five as four hundred and forty pounds of tob^o which to the same Thomas Darshell in our Court before us were adjudged for his Costs and damages sustained by omission of the detaining of the same Debt by him about his Suit in that part expended, if the afo^r Randall and Anthony West have so much goods and Chattells which were of the afo^r Catherine West at the time of her Death, in their hands remaining to be administered, & if so much in their hands they have not, then the damages and Costs afo^r of the proper goods and Chattells of the afo^r Randall & Anthony West to be levied, and when you have the same so made a any part thereof, the same safe keep so that you have the same before the Juries of the County Court to be had at deciding first the third Tuesday of November next to render the afo^r Thomas Darshell his Debt and damages afo^r whereof they are Committed have you then and there this writt.

Done One thousand Seven hundred and twenty eight Came the afo^r Thomas Darshell by Levi Gale his attorney and the Sheriff of Somerset County to whom the foregoing writt was Directed Likewise Cometh maketh Return thereof to the Court here Endorsed in these words following viz^t -

By virtue of the within writt come directed to the Juries within named I certify that the afo^r within named the goods and Chattells of the within named Cath^l West the testant have altogether waisted so that the within ten thousand Seven hundred and Ninety four pounds of tob^o Debt of four hundred and forty pounds of tob^o Costs within mentioned nor any part thereof at present I can cause to be made as by the said writt I am Comanded -
