Whereupon the said Thomas Holbrook present herein Court acknowledged himself to owe and stand justly indebted unto his Lordship the Lord Proprietary in the sum of Ten pounds sterling good and lawful money of England of his goods and chattels lands or tenements to be made &c. levied for the use of his said Lordship his heirs and Successors if default be made in the condition hereunder written. The condition of this Recognizance is such that if the above Bounden Thomas Holbrook shall personally appear at the next Court to be hold at Dividing Creek the third Tuesday of June next, to do and Receive what shall be then and there enjoined him by the Court, and in the mean time to be of the good behavior towards his said Lordship and all others his good people and more Especially towards aforesaid Thomas Godard &c. then the above Recognizance to be void otherwise &c.
