County to whom the foregoing writ was directed Likewise Cometh and maketh return there
of to the Court here Endorsed vizt. Capi Coram of Fran: Allen Esq -

And the said John Blizard by Fran: Allen his attorney Comes and defends the force
and Injury when &c and prays Leave to Dispute here unto until the next Court and he hath it
and the same day is given to the said Esq here also &c.

At which said next Court to with the nineteenth day of November and Dow. One thou:
: said Seven hundred and twenty eight Come again as well the said Nathaniel as the said
John by their attorneys and thereupon the said John by his said attorney prays
further Leave to Dispute hereunto until the next Court and he hath it and the same day is
given to the said Esq here also &c.

At which said next Court to with the eighteenth day of March and Dow. One thou:
: said Seven hundred and twenty eight Come again as well the said Nathaniel as the said
John by their attorneys and thereupon the said John by his said attorney offers himself
against the said Nathaniel, but the said Nathaniel being solemnly called Cometh not nor is his
writ against the said John further prosecuted &c -

Therefore it is considered that the said Nathaniel Holliston and his
edges of Prosecuting be in mercy, and that he name his pledges &c and that the said John
goe thereof without day also it is considered that the said John Blizard recover against
the said Nathaniel Holliston One hundred and Sixty Six pounds of tobacco for his costs
and charges to the same John by direction of the Justice here at his request in that part.
