Att which said next Court to wit the seventh day of June and Dowd one thousand seven hundred and twenty nine came again as well the said John Donelson as the said Robert Collier by their attorney, and hereupon the said John Donelson by his said attorney Comand that he will no further prosecute his writ and against the said Robert Collier in the County of &c.

Therefore it is considered that the said John Donelson take nothing by his writ and but be in mercy for his false Comand and that the said Robert Collier and go thereof without Day, and also it is considered by the Justices that the said Robert Collier Recover against the said John Donelson Two hundred Twenty Two pounds of t^l for his Costs & Charges by him about his Defense in that part sustained according to the Form of the Statute in such Case lately made and provided, and that the said Robert have none of his Execution &c.
