 Hasbrook who being duly Oathed tried and sworn to say the truth in the premises upon their Oaths
 do say that the vs William West did assume upon himself in manner and form as the vs Thomas
 Dashiell above against him hath Complained and do as yet the damage of the same Thomas Dashiell by reason
 of the non performance of the promise and assumption vs beyond his Cost and Charges by him about
 his suit in that part apposed to five hundred and fifty eight pounds of tobacco and for those Cost and
 Charges to One pound of tobacco

Therefore it is Considered that the vs Thomas Dashiell Recover against the vs Wm.
 West his damages ^{by the Jurors aforesaid} as also Six hundred and Eighty One pounds of tobacco for his
 Cost and Charges vs to the same Thomas Dashiell by the Court here of his vs Dues as adjudged
 which Certain Damages in the whole do amount to twelve hundred and forty pounds of tobacco, and of
 aforesaid vs in mercy vs

 Writ. John Bishop } of Jurisdiction against the vs the tenor whereof followeth in these words

Somerset^{sh}. Charles absolute Lord and Proprietary of the provinces of Maryland
 and Colon Lord Baron of Baltimore vs To the Just. of Somerset County greeting whereas
 Joseph M^r Clerk in our County of Somerset here to wit, vs after the day of
 March One thousand seven hundred twenty five before said Hopkins Gent^l
 his associates then Justices of our said Co^{ty}: at dividing Creek by Consideration
 of the same Co^{ty}: recovered against John Bishop late of Somerset Co^{ty}: Eight
 Hundred & thirty two pounds of tob^o: for his Dam^t: which he sustained
 by Occasion of a certain Promise & assumption to the same Jos: by vs and
 Jus^{ts}: M^r Clerk made & performed whereof he is Convict as by the Record &
 Process there of in our same Court before our Justices at dividing Creek remain-
 ing Manifestly appeareth Nevertheless Execution of vs Judgment: as yett
 to main^t: to be Made as by the Insurrection of vs Jos: we have received because
 we are Willing that those things which in our same Court are right fully Done
 should be duly Executed, Command you that by honest & Carefull Man of
 your Bailiwick you Make known unto the vs Jus^{ts}: Bishop that he be, before
 our Justices of our Co^{ty}: of Somerset to be Held at dividing Creek by this day
 of Novemb^r: Next to shew Cause if any for himself he hath or knoweth
 to say wherefore the vs Jos: M^r Clerk Execution against him of vs Judgment
