 from all Damages and Costs which he should sustain by Quarrel thereof would well and faithfully
 Content and pay and the said Ald. in farr say that he the said Ald. trusting to the promise &
 abumption aforesaid of d. aforesaid William Smith so as aforesaid made the day and year aforesaid at County aforesaid
 and within the aforesaid Jurisdiction in the County Court aforesaid at the Expecial Durstane & requested aforesaid
 William Smith did become Special Bail for the said Wm. Francis whereby the said Ald.
 afterwards to wit sixteenth day June anno dom: One thousand seven hundred & Twenty Six at
 the County aforesaid and within the aforesaid Jur. did sustain damage and to the said Copele D'ing aforesaid been
 obliged to pay two pound three Shillings and many of nine hundred & forty six pounds at
 100d. of which the said William Smith afterward to wit same day and year aforesaid mentioned
 at the County aforesaid and within the aforesaid Jurisdiction by the same Ald. had Notice & therfore
 was requested to save the same Ald. harmless and to pay him the said sum of two pd. three shill.
 and many and nine hundred and forty six pd. aforesaid Nevertheless to wit Wm. Smith his
 Brevis and abumption aforesaid in farr aforesaid made not regarding but plotting & fraudulently
 Intending him the same Ald. in that part craftily & Nobly to Defraud and Deceive the
 said William Roberts to the said Ald. the said sum of mony £100. or any part thereof to
