I Nd whereupon the same Thomas by Lewis Gale his attorney complained that whereas he the said Thomas the tenth day of December and Dowd. One thousand seven hundred and twenty six at Somersett County within the Jurisdiction of this Court demised unto the afo Catherine a certain Mesuage and ~~one hundred~~ acres of Land with the appurtenances in the County and to have and to enjoy by the said Catherine her Executors and admt. from the afo tenth day of December for the space and term of one year next following fully to be compleat and ended rendering and therefore unto the said Thomas the quantity of five hundred pounds of tobacco and the said Catherine afterwards bid. the same day and year afo at the County afo and within the afo Jurisdiction in consideration of the said demise so as aforesaid made upon herself affixed and to the said Thomas then and there faithfully did promise that she when she should be thereunto requested after the Expiration of the term afo of one year the afo Mesuage and one hundred acres of Land with the appurtenances unto the said Thomas would deliver in as good repair as she received also the said five hundred pounds of tobacco unto the said Thomas would well and faithfully pay and give, notwithstanding the said Catherine her promise and agreement afo in forme afo made Little Regarding but plotting and fraudulently Intending him the said Thomas in that part faithfully and Subtly to defraud and deceive the said Mesuage and one hundred acres of Land with the appurte- nances after the Expiration afo of the term afo unto the said Thomas hath not in as good order and repair as at the receiving, the same delivered, nor the said Thomas the quantity of five hundred pounds of tobacco or any Part thereof paid or paid for it - Butted altho. the said Catherine the same to do after the making the promise and agreement afo the Expiration of the term afo bid. the tenth day of January and Dowd. One thousand seven hundred and twenty eight at Somersett County afo within the afo Jurisdiction by the same Thomas was Requested but the same hitherto to do hath altogether refused and still doth refuse whereby the same Thomas says he is worse and hath damage to the value of six thousand pounds of tobacco and thereof he brings his Suit & Lewis Gale Esq; his Lawyer & his Docket

I Nd the aforesaid Catherine Dyall by Francis Allen her attorney comes and defendeth the force & injury when &c. and praye leave to Imparte hereto until the next Court and the same hath it and therefore day is given to the afo Clerk here afo

One thousand seven hundred and twenty eight Comer again as were the afo Thomas Walker as the afo Catherine Dyall by her attorney afo, and the afo Catherine Dyall by her said attorney pray further leave to Imparte hereto until the
