Att which said Next Court to witt the seventeenth day of the same month and eleven hundred and twenty nine came again as well the app Thomas Walker as the app Catherine Dyale by their attorney app, and the said Thomas Walker by his said attorney prays that the app Catherine Dyale to his declaration app may answer, and the app Catherine Dyale altho. at the same day solemnly called Cometh not nor nothing says in bar or Exclusion of the action app of the app Thomas Walker, by which the same Thomas Remaineth against the app Catherine hereof Undersaid

Wherefore the app Thomas Walker his damages against the app Catherine Dyale by occasion of the non performance of the promise and assumption app ought to recover, but because it is not known to his Lordship's Justice here what damage the same Thomas in that part <sup>has</sup> sustained, Therefore Command is to the Sher. of Somerset County, that by the oath of honest and Lawfull men of his Bayliwick or County he diligently Enquire what damage the same Thomas has sustained as well by occasion of the non performance of the promise and assumption app as for his Costs and Charges by him about his Suit in that part aforesaid, and the Inquisition which thereof he takes to his Lordship's Justice at dividing Creek in Somerset County app <sup>the third Tuesday of August Next</sup> under his Seal and the seals of them by whose oath he makes the same Inquisition he send together with his said Lordship's writ to him thereof directed and the same day is given to the app Catherine Dyale <sup>there</sup> also. - At which third Tuesday of August to witt the nineteenth day of the same month and Dow. One thousand Seven hundred and twenty nine before his said Lordship's Justice at dividing Creek in the County app Cometh the app Thomas Walker by his attorney app and the Sher. of Somerset County viz. John Burnale Gent. Returned after said Inquisition before that at Wickhamore in County app on the fifteenth day of August and year app by the oath of honest and Lawfull men of his Bayliwick taken by which it appears that the app Thomas Walker has sustained damage by occasion of the non performance of the promise and assumption app beyond his Costs and Charges by him about his Suit in that part aforesaid to five hundred pence and for those Costs and Charges to one pound of tobacco -

Therefore it is Considered that the app Thomas Walker Recover against the app Catherine Dyale five hundred pence and one pound of tobacco his damages app <sup>as by the Inquisition app above appears</sup> and <sup>gounds of tobacco for his Costs and Charges by him</sup>

One thousand Seven hundred and twenty eight at Somerset County within the Jurisdiction of this Court was indebted unto the same Joseph in the sum of One thousand gounds of tobacco for the like sum to sundry persons before that time for his use and at his request by the same
