Heatch to lay out a piece of Land given him by his father Adam Heatch & was Brought to an old Gum Stump standing about one hundred yards to y^e Southward of y^e J^r. Princes House on y^e East side of a glade of y^e Mill Branch which said Stump they told this Depout. was where Francis Saucakes Land ended on y^e South East side of said Saucakes Land & this Depout. Began their Land out. Said Sam^l. Heatches Land by a Line of Marked trees & further Saith not Taken before us y^e Subscribers this 28th Day of July 1729
