William West - } to answer unto Vachel Denton of a plea of her part upon the case &
And whereupon the said Vachel by Levi Gale his attorney complains

That whereas the said William the tenth day of May and David one thousand seven hundred and Twenty Seven at Somerset County within the Jurisdiction of this Court was indebted unto the said Vachel in the sum of two pounds fifteen shillings and one penny Court money upon the Ballance of an a/c. herewith in Court produced and so thereof being indebted the said William in consideration thereof afterwards to wit the same day and year a/c at the County a/c and within the a/c Jurisdiction upon himself assumed and to the said Vachel then & there faithfully promised that he when afterwards he should be thereto requested he the a/c sum of two pounds fifteen shillings and one penny Court money to the said Vachel would well and faithfully content and pay Nevertheless the said William his promise and assumption a/c in form a/c made little regarding but plotting and fraudulently him the said Vachel in that part craftily and sulkily to defraud and deceive he the a/c sum of two pounds fifteen shilling and one penny Court money or any part thereof to the said Vachel hath not paid or him for it in any wise contented altho' the said William the same to do afterwards to wit the same day and year a/c at County a/c and within the a/c Jurisdiction ^{was} thereto requested but he the same to do hitherto hath altogether refused and shew doth before whereby the said Vachel say he is worse and hath damage to the value of five pounds Court money and hereof he brings this suit &c. Gale of Qu. Sledge of a/c do a/c &c.

Whereupon the said William West appears and thereupon the said William West at the prayer of the a/c Vachel by his attorney a/c is adjudged to give special bail to the action a/c thereupon the said Randall West of Somerset County planter present here in Court undertakes for the said William West that if in case the said Vachel Denton should recover Judgment in the plea a/c against the said William West or that the said William West shall be therein found that then he the said William West shall pay or condemnation of the Court thereupon or tender his body to the custody of the sherrif of Somerset County in satisfaction thereof or that he the said Randall West will do it for him.

Whereupon the said William West by Francis Allen his attorney comes and defends the force and injury when &c. and say that he cannot gain say the action a/c of the a/c Vachel nor but that he did assume upon himself in manner and form as the a/c Vachel above against him hath complained and as to the damage of the said Vachel by him by reason of the premises in that part instanced the same William says and confesseth that the a/c Vachel has instanced damage by reason of the premises beyond his costs and charges by him about his suit in that part appored to two pounds fifteen shillings and one penny Court money and not more and because the a/c Vachel deny not this but the same allegation confesseth to be true pray Judgment and those Damages above confessed together with his costs and charges a/c to him adjudged &c.
