At which said next Court to wit the seventeenth day of June and Dow. One thousand seven hundred and twenty nine came again as well the afo *John Hendry* as the afo *Rachell Alexander* by their attys afo and whereupon the afo *Rachell* by her said attorney prayed further leave thereof to *Impar* hereunto until the next Court and she hath it and the same day is given to the afo *Edm* here also &c ---

At which said next Court to wit the nineteenth day of August and Dow. One thousand seven hundred and twenty nine came again as well the afo *John Hendry* as the afo *Rachell Alexander* by their attorneys afo and whereupon the afo *Rachell* by her said attorney prayed further leave thereof to *Impar* hereunto until the next Court and she hath it and the same day is given to the afo *Edm* here also &c ---

At which said next Court to wit nineteenth day of November and Dow. Wherefore the said *John* his damages by reason of the premises against the said *Rachell* ought to recover &c upon the Justice and equity of the Court &c the damages of the said *John* by and by his charges to forty two pounds for his equal money
Therefore it is Cou^{rt} Ordred that the afo *John Hendry* Recover against the afo *Rachell*

Alexander admts of the afo *Henry Alexander* del. his damages afo to forty two pounds from *Stidings* & five pence *Cur* money of *Maryland* as also three hundred and thirty eight pounds of *Tobacco* for his *Costs* and *Charges* to the said *John Hendry* at his request by the Court here of his afoent adjudged, of the goods and Chattels which were of the afo *Henry Alexander* at the time of his death in the hands of the afo *Rachell* remaining to be admitted if so much in her hands she hath, and if so much in her hands she hath not then the *Costs* afo to be levied of the proper goods and Chattels of the afo *Rachell* and afo *Edm* left in mercy &c
