plotting and fraudulently intending her the said Margt. in that part craftily and slyly to deceive
and defraud the gelding afo altho. after thereto requested unto the said Margt. hath not delivered
but the gelding afo afterwards that is to say the same day and year afo at the County afo within the
Jurisdiction afo to his own proper use and behoofe did dispose and convert whereby the said Margt
says she is worse and hath damage to the value of twenty pounds current money and thereof she brings

At which said next Court to wit the seventeenth day of June and Dow. One
thousand seven hundred and twenty nine came again as well the sd Margrett Waile as the sd
John Tilman by their attorneys afo and whereupon the sd John Tilman by his said attorney pray-
ed further leave to Impale hereunto until the next Court and he hath it and the same day is given
to the sd Pleth here also &c.

At which said next Court to wit the nineteenth day of August
and Dow. One thousand seven hundred and twenty nine came again as well the sd Margt Waile
as the sd John Tilman by their attorneys afo and whereupon the sd John Tilman by his said
attorney prayed further leave to Impale hereunto until the next Court and he hath it and the
same day is given to the sd Pleth here also &c.

eenth day of November and Dow. One thousand seven hundred and twenty nine came again as
