 said Francis the said eight thousand pounds of tobacco in manner and form as the said Francis above
 against him hath declared &c

Therefore it is considered by the Court here that the said Francis Allen recover against the
 said Ebenezer Seamore eight thousand pounds of tobacco his debt and his damages by occasion of the
 detaining of the same debt to five hundred & Twenty Nine - - - pounds of tobacco
 52 To the same Francis of his cost by the Court here adjudged and the said debt in money &c where
 upon the said Francis by his attorney and qualis here in Court remitteth to the said Ebenezer the said eight thou-
 sand pounds of tobacco. Therefore it is considered that the said Ebenezer of the said eight thousand pounds of
 tobacco be acquitted &c

 Seven hundred and twenty Six at Somerset County within the Jurisdiction of this Court by his
 certain Writing Obligatory granted himself to be held and bound by Bond unto the same
 Francis in the sum of eight thousand pounds of tobacco to be paid the same Francis when after-
 ward the said William should be thereto Required the said eight thousand pounds of tobacco
 to the same Francis hath not tendered but the same hitherto to do hath altogether denied
 and still doth deny and unjustly detain whereby the same Francis says he is worse and
 hath Damage to the value of sixteen thousand pounds of tobacco and there of he brings this suite
 and the same Francis brings hereinto Court the writing obligatory and which the debt
 is in form and Wittnesse whose Date is the same Day and Year and
