 steal take and carry away against the form of the act of assembly of this province in such Case made and provi-  
 ded and against the peace of the right Honble the Lord Proprietary that now is, his good rule and Govern-  
 ment &c.

 premises aforesaid and thereupon a certain John Handy of Somerset County Gent. present here in Court undertakes for the said Charles  
 Buckworth to pay the severall Officers their fees due by Oath of the premises aforesaid &c.

David Ailwood appears according to his Recognizance Entered into before John Handy of Somerset County Gent. and one  
 of his Lordships Justices of the peace for the County aforesaid, for his good behaviour and appearance at this Court &c.  
 Whereupon the Court hereinto Cometh the said David Ailwood in his proper person and prays that his appearance may be recorded  
 to save himselfe and security from a certain Recognizance of Oath Entered into as aforesaid &c.  
 Thereupon the said David Ailwoods appearance is recorded and he and his securitys accordingly discharged &c. where-  
 upon it is ordered by the Court here that the said David Ailwood give security for the severall Officers their fees due by Oath of the  
 premises aforesaid and thereupon a certain Aaron Lynn of Somerset County present here in Court undertakes for the said David Ailwood  
 to pay the severall Officers their fees due by Oath of the premises aforesaid &c.
