twenty nine came again as well the said Richard Waters as the said Nathaniel Horsey by their attorney, and  
and the same Nathaniel by his said attorney Gray further leave thereof to Impare his wits until the next Court  
and he hath it and the same day is given to the said Left hand also

At which said next Court to wit the Eighteenth day November and One thousand seven hundred and  
twenty nine came again as well the said Richard Waters as the said Nathaniel Horsey by their attorney,  
and the said Nathaniel Horsey by his said attorney Gray, further leave thereof to Impare his wits until the  
next Court and he hath it and the same day is given to the said Left hand also

At which said next Court to wit the seventeenth day March and One thousand seven hundred  
and twenty nine came again as well the said Richard Waters as the said Nathaniel Horsey by their attorney,  
and the said Nathaniel Horsey by his said attorney Gray, further leave thereof to Impare his wits  
until the next Court and he hath it and the same day is given to the said Left hand also

At which said next Court to wit the sixteenth day of June and One thousand seven hundred and  
twenty nine came again as well the said Richard Waters as the said Nathaniel Horsey by their attorney, and the  
said Nathaniel Horsey by his said attorney as before defends the force and injury upon the said Nathaniel  
afore upon himselfe in manner and form as the said Richard above against him hath Complained and of this  
he putt himselfe upon the Country and the Left in like manner

Therefore at the prayer of the Left and Right by their attorney, Command is given to the Sher. of  
Somerset County that he cause to come here the Twelve by whom who willor to recognize because a  
warrant which said Sheriff the said Sher. to wit John Curmule Gent. Now last the same day and year last  
mentioned Comes and makes Return that he hath here ready Twelve as by his said Sheriff he was Commaunded  
and now here afterwards to wit the same day and year came as well the said Left as the said Right by their attorney,  
and the jurors of that Jury thronid Imparalled being called came to wit John Fustace, Patrick Latchey  
Archibald Stirling, John Donelson, John Stewart James Lindsay, David Beuchamp Wm. Mc Ginnery John  
Holland Johnson Hill, David Herd John Scarborough - who being duly elected tryed and sworn to say the  
within the premises upon their oath doe say that the said Nathaniel Horsey did afores upon himselfe in manner  
and form as the said Richard above against him hath Complained and do afores the damages of the same Richard beyond  
his Costs and Charges by him about his suit in that part apposed to two pounds seven shillings Current Money and for  
three Costs and Charges to one pound of tobacco

Therefore it is Considered that the said Richard Waters Recover against the said Nathaniel Horsey his  
damages and by the jurors as afores to two pounds seven shillings Current Money and one pound of  
tobacco as also three hundred and three pounds of tobacco for his Costs and Charges and to the  
said Richard by the Court hee of his part of Increase adjudged what certain damages in the whole do amount to  
two pounds seven shillings Current Money three hundred and three pounds of tobacco and  
the said Right in Money
