At which said next Court to witt the Eighteenth day November and One thousand seven hundred and
twenty nine came again as well the said Richard Waters as the said Nathaniel Horsey by their attorney,
and the said Nathaniel Horsey by his said attorney Gray, further leave thereof to Impare his wits until the
next Court and he hath it and the same day is given to the said Left hand also &c.

At which said next Court to witt the seventeenth day March and One thousand seven hundred
and twenty nine came again as well the said Richard Waters as the said Nathaniel Horsey by their attorney,
and the said Nathaniel Horsey by his said attorney Gray, further leave thereof to Impare his wits
until the next Court and he hath it and the same day is given to the said Left hand also &c.

At which said next Court to witt the sixteenth day of June and One thousand seven hundred and
twenty nine came again as well the said Richard Waters as the said Nathaniel Horsey by their attorney, and the
said Nathaniel Horsey by his said attorney as before defends the force and injury upon the said and said that he did not

his Costs and Charges by him about his suit in that part apposed to two pounds seven shillings Current Money and for
three Costs and Charges to one pound of tobacco &c.

Therefore it is Considered that the said Richard Waters Recover against the said Nathaniel Horsey his
damages as by the Jurors as is informd as aforesaid to two pounds seven shillings Current Money and one pound of
tobacco as also three hundred and three pounds of tobacco for his Costs and Charges as to the
said Richard by the Court has of his part of Increase adjudged what certain damages in the whole do amount to
two pounds seven shillings Current Money three hundred and three pounds of tobacco and
the said Right in Money &c.
