John Murray - - - - - Somerset County Abraham Smith late of Somerset County planter was attested to answer  
 unto John Murray of agree after pass upon the Court. And Whereupon the said John by Francis Allen his attorney complainant that whereas the  
 said Abraham the first day of November and anno Domini seven hundred and twenty eight  
 at Somerset County and within the Jurisdiction of this Court was indebted unto the said John in fourteen pounds seven  
 pence and five pence current money of Maryland being a week for sundry goods wear and merchandise by  
 the said John to the said Abraham at the speciall instance and request of the said Abraham before that time there  
 sold and delivered as for sundry sumes of money by the said John for the said Abraham before that time had beene  
 paid and paid at the said speciall instance and request of the said Abraham as by amount hereto annexed may appear  
 and being so longe off debited the said Abraham in Consideration whereof the day and year aforesaid at the place and within the  
 Jurisdiction aforesaid upon himselfe did affirme and to the said John then and there did faithfully promise that he the said  
 Abraham the said fourteen pounds seven pence and five pence to the said John whom he should be afterwards remitted requested  
 he would wee and faithfully pay and content and alio. the said Abraham afterward did deliver and pay unto the said  
 John seven pounds and three pence per cent of the aforesaid fourteen pounds seven pence and five pence, yet to seven pounds  
 seven pence and two pence residue of the said fourteen pounds seven pence and five pence the said Abraham his  
 promise and assumption aforesaid made nothing regarding but clothing and fraudulently intaking the said John  
 in that part craftly and subtilly to deceive and defraud the said seven pounds seven pence and five pence to the  
 said John alio. he same to do the same Abraham by the same John the aforesaid first day of November in the year aforesaid and often  
 afterwards at Somerset County and within the Jurisdiction and so way remitted he not paid or to him further sume  
 in any wise accounted but the same to him hitherto to pay or in any sort to content hath altogether refused and sheweth  
 Refuse and deny wherupon he saith he is worse and hath damage to the value of fourteen pounds money and thence
