The Said W^m in Consideration thereof afterwards to witt of same Daye year and
at y^e C^t y^e off & within y^e J^r upon himselfe assumed & to y^e same Randall then

ted he y^e aff^d sum of Six hundred pence to y^e same Randall woud well &
faithfully content & pay Nevertheles^s w^t his promise easynge him

him y^e same Randall in y^e part craftily & Subtilty to defraud & deceiv^e

paid although y^e same to doe w^t aff^d W^m afterwards by y^e same daye year and

hitherto to doe hath altogether refused & still doth refuse whereby y^e same
Randall sayes he is worse & hath damed to y^e value of twelve hundred pence &

And the aff^d William Comiter in his own proper person comes and defauds the same and Injury when
y^e and says that he cannot gainsay but he y^e promised and assumed upon himselfe in manner and form
as the aff^d Randall above against him declared, nor can he say but that he owes the aff^d Randall

Therefore it is considered by the Court here the twentieth day of June and D^d One thousand
seven hundred and twenty seven that the aff^d Randall West Recover against the aff^d William Comiter six
hundred pence his Damages and also Two hundred & Twenty two — — — — — pounds aff^d
for his Cost and Charges by him about his suit in that part Expended to the same Randall by the Court here
of his appeal adjudged and the aff^d Deft^d in Mercy ^{ll}
