AND further it is Ordered by the Court that the said Samuel Dorman give Recognizance with two Sureties for to Comply with the Law in Every Respect in Relation to Guardians and to deliver up unto the said William Stevens all the Estate that he hath in his hands both Real and personal when he shall arrive at full age to receive the Same Peaceably and Quietly &c

Whereupon the said Samuel Dorman, together with Nicholas Hountain Junr. and Solomon Tull all of Somerset County Clerks Present herein Court in their proper persons, acknowledged themselves to owe unto the said William Stevens his heirs and assigns that is to say the said said Dorman the sum of twenty Pounds Sterling, and the said Nicholas Hountain & Solomon Tull his Surety the sum of ten Pounds Sterling each, to be Separately Provided upon their body, goods or Chattels Land, or Tenements for the Use of the said William Stevens his heirs and assigns if Default be made in the Condition hereunder written

The Condition of the above Recognizance is such that if the above Bounden said Dorman do Comply in every respect with the Law in Relation to guardians, and deliver up unto the said William Stevens Peaceably, and quietly, all his Estate, that he hath in his hands both Real and Personal, when he shall arrive at full age to receive the Same & then the above Recognizance to be void and of None Effect otherwise to remain in force & virtue

Samuel Dorman of Somerset County Clerk agrees with the Justice of Somerset County Court, to keep a ferry over Coromocke River in the stead of Daniel Ordery and to find a good Boat, and give good attendance for the ferrying of man and horse over the said River of Coromocke, and to keep that halfe of the Causeway in Repair that is next the ferry &c

In consideration whereof the said Samuel Dorman is to be allowed for the services aforesaid the Sum of three thousand six hundred pounds aforesaid by the Year &c

Ordered by the Court that Philip Duntou be Overseer, and Repair that halfe of the Causeway at Coromocke ferry, next the woods, and so to his usual Quitts

Mary Wharton an Orphan is bound by the Court unto Solomon Tull until she arrives to the age of sixteen she being Eleven years of age the fifteenth day of December next, the said Mary Wharton to serve the said Solomon Tull the full term of time aforesaid, In consideration of which servitude the said Solomon Tull undertakes for to give her regular schooling during her servitude, and at the Expiration of her servitude to give her a young Cow and Calf, and a suite of Cloaths of good worked stuff &c

Thereupon the said Solomon Tull is ordered by the Court to give Recognizance, with two Sureties in the Sum of thirty pounds Sterling good and Law full money of England to the Use of the said Mary Wharton in Case the said Solomon Tull doth not Comply with Covenants aforesaid. Whereupon the said Solomon Tull, together with Samuel Dorman and Nicholas Hountain Junr. his Sureties all present herein Court in their proper persons acknowledged
