indebted to the same d^r: when afterward he should be there unto requested & d^r Jos:
in fact says that the same Tho: Mayor at d^r time of the making d^r Note and was indebted
unto the same d^r: in a sum of two thousand five hundred & Ninety three pd^d of tobo
which is yet unpaid to the same d^r: whereof the same Henry afterward (viz) the
