 Given to the afo^d Clerk here also ^{to}

At which said court to wit the twenty first day of Novemr anno domini
 thousand seven hundred and twenty seven came again as well the afo^d Thomas by his
 said attorney, as the afo^d John Murray in his own proper person, and the said John says,
 that he cannot gainsay the action afo^d of the afo^d Thomas, nor but that the said Edward Bray
 in his life time did assume upon himself in manner and form as the afo^d Thomas above
 against him hath complained, nor can he say but that the said Thomas ought to recover his
 damages by reason of the non performance of the promise and assumption afo^d to one
 thousand and twenty seven pounds of tobacco, to be levied of the goods and chattels which were
 of the afo^d Edward at the time of his death being not administered, and which to his hand,
 hereafter should happen to come to be administered &c.

Therefore it is considered by the court here the same day and year last -
 mentioned that the afo^d Thomas Dashiell Recover against the afo^d John Murray Executor of
 the afo^d Hugh Porter who was Executor of Edward Bray, One thousand and twenty seven
 pounds of tobacco his damages afo^d above in the declaration afo^d expressed as also two
 hundred and fifty nine - pounds of tobacco for his fees and charges by him about his suit
 in that part executed to the same Thomas by the court here of his afo^d adjudged to be levied
 of the goods and chattels which were of the afo^d Edward Bray, at the time of his death
 and which to his hand, off the afo^d John hereafter should happen to come to be administered
 and the afo^d debt in money &c -
