Brice, Elizth. Ackman, Thomas Mumford and Catherine Diale so as afo presented It is ordered that Captains Spue returnable to next Court &c

Thomas Sirman son of Edward Sirman being arrived at full age to chose his guardian, comes herunto Court and pray that he may be admitted to chose afitam John Collins as his guardian &c which is granted &c Thereupon the said John Collins present hereni Court in his proper person is ordered to give recognizance with one security in the sum of fifty pounds lawfully and severally to comply with the Law in relation to guardian's &c

Thereupon the said John Collins together with Adam Hitch his Security both present here in Court in their proper person, acknowledged themselves to Owe and stand Justly Indebted unto
