Robt Wood } bound to
Wm. Scott } Robert Wood, son of Robt Woods, decd, aged sixteen years the nineteenth day of August next, being present herein Court, is bound by the same Court of his own Consent unto William Scott until he arrives at the age of twenty One years, the said Robert Woods to serve the said William Scott the full term of time aforesaid. In consideration of which servitude the said William Scott undertakes to learn the said Robert Wood during his servitude to read write and Cypher, and the trade of a Shoemaker, and at the expiration of his servitude to give him a sett of Shoemakers Tools and to find him sufficient meat drink washing Linnen and Cloathing mete for such a servant to have and wear &c.

Whereupon it is ordered by the Court that the aforesaid William Scott give good security for to comply with the covenants aforesaid. Thereupon the said William Scott, with William Hall his

Security both present herein Court acknowledged themselves to owe and stand Justly Indebted unto the said Robert Woods in the sum of forty pounds Sterling good and Lawfull money of England to be levied of the body, goods, or Chattells Lands, or tenements, for the use of the said Robert Woods, his heirs or assigns if default be made in the condition hereunder written &c.

The condition of the above recognizance is such that if the above bound William Scott do and shall during the servitude of the said Robert Woods, learn him to read write and Cypher and at the expiration of his servitude give him a sett of Shoemakers Tools, and find him sufficient meat drink washing Linnen and Cloathing during his servitude aforesaid mete for such a servant to have and wear then the above recognizance to be void &c. otherwise &c.

Nicholas Gray } bound to
Nicholas Warren } Nicholas Gray son of John Gray decd is bound by the Court of his own Consent unto Nicholas Warren until he arrives at the age of Twenty One years he being fifteen years of age the last day of September next, the said Nicholas Gray to serve his said Master the full term of time aforesaid &c.

In consideration of which servitude the said Nicholas Warren undertakes to learn the said Nicholas Gray to read and write and the trade of a Shoemaker and at the expiration of his servitude to give him a sett of Shoemakers Tools and to find and provide for him sufficient meat drink washing Linnen and Cloathing mete for such a servant to have and wear during his servitude aforesaid &c.

Thereupon it is ordered by the Court that the aforesaid Nicholas Warren give recognizance with due security to comply the covenants aforesaid &c.

Whereupon the said Nicholas Warren with William Walton his Security both present herein Court acknowledged themselves to owe and stand Justly Indebted unto the said Nicholas Gray in the sum of forty pounds Sterling good and Lawfull money of England to be levied of the goods and Chattells Lands, or tenements for the use of the said Nicholas Gray for
