The Condition of the above Recognizance is such that if the above bounden Richard Hudson do and shall make his personal appearance before the Justice of his Lordship's County Court of Somerset to be hold at Dividing Green the third Tuesday of June than Next to answer unto his said Lordship concerning all such Matters and things as shall be then and there objected against him on his Lordship's behalf and to stand and abide the Judgment of the Court thereon and not to depart the same Court without Licence thereof then the above Recognizance to be void us.
