Hendrey in Custody as af, Twenty two pound, Nine shillings, and Nine pence halfe Penny Curr. money his damages af by the Justice af as afed as also four hundred and thirty pound, off. tobacco for his Costs and Charges by him about his suit in that part Extended to the same Alex. by the Court here of his afent adjudged and the af Defend<sup>t</sup> in mercy &c.

Afterwards viz. the same day and Year last mentioned the said J. Hendrey present here in Court, is at the prayer of the af Alexander by his attorney af Committed into the Custody of the Sher. of somerset County there to remain until the af Alexander of the damages and Costs af should be fully satisfied, the said Sher. being present here in Court took Charge of the said J. Hendrey accordingly &c

Charles absolute Lord and Proprietary of the provinces of Maryland and Avalon Lord Baron of Baltimore To the Sher. of Somerset County greeting, Whereas a certain Benj<sup>t</sup> Wailes late of Somerset County Gentle lately in our City Court of Somerset heretofore the fiftenth day of March Ann<sup>d</sup> Dow. one thousand seven hundred & twenty five before said Hopkins & his associates than our Justices at Dividing Creek in our City af assumed upon himselfe & did undertake for a certain James Scott late of Somerset County Manner that in case a certain Andrew Scott should discover Judgment against the said James in a certain Plea of trespass upon the Case by the same Andrew against the af James in our same Court prosecuted, or that the said James should be therein convicted that then, the same James, all the Damages which to the same Andrew in our same Court here in the af Plea of trespass upon the Case af that should be adjudged, would satisfy or his body in Execution of such Judgment to the Sher. of Somerset County would tender or that he the said Benj<sup>t</sup> Wailes would do the same for him & altho, the af Andrew afterwards to witt the sixteenth day of November Ann<sup>d</sup> Dow. one thousand seven hundred & twenty six in our same Court here before the same said Hopkins Gent & his associates than our Justices of Somerset County Court at Dividing Creek af by consideration of the same Court recovered against the af James three pound, eight shill & Nine pence Curr. money & three hundred & thirty &c
