Therefore by consent of the parties aforesd it is Considered that the aforesd Hugh Barker Recover against the aforesd James Rawland in Custody as aforesd his Damages and to the aforesd term pounds Seven Shillings and eight pence half-penny Current Money by the same James Rawland in Custody aforesd Confessed as also two hundred and fifty one pounds of tobacco — for his Cost and Charges aforesd to the same Hugh at his Request by the Court here consent of the parties aforesd adjudged £<sup>0</sup> and the aforesd left in Custody as aforesd in Mercy &c.
