Whose upon the Said Moses Duskey Garnisher of the afo^r: Richard Duskey altho' Solemnly Called Comes not Nor Shows Cause why &c: but makes default.

Therefore upon the Said John Burnall by his attorney afo^r: present before me prays that upon Giving Security according to act of Parliament in such case made and provided the afo^r: Sum of twelve hundred and fifty pounds of Tobacco so as afo^r: attached in the hands of the aforesaid Moses Duskey may be condemned as of the goods and Chattels Rights and Credits of the Said Richard Duskey towards Satisfying unto the Said John Burnall the afo^r: twelve hundred and fifty pounds of Tobacco in the writ afo^r: mentioned as also all Costs accruing upon the Same writ &c

Whose upon Francis Allen of Somerset County Gent present before me undertakes for the Said John Burnall that if in case the Said Richard Duskey do at any time within a year and a day appear and make all or any part of the Said John Burnalls Claim against him appear to be Satisfied ^{or any way} to have been due before the laying of this attachment that then the said John Burnall shall make Restitution unto him the Said Richard Duskey of all or such part thereof as shall be made appear to be due &c: or that he the Said Francis Allen will doe it for him &c

Therefore it is Considered by the Justice here that the aforesaid sum of twelve hundred and fifty pounds of Tobacco so as afo^r: attached be condemned in the hands of the Said Moses Duskey as of the Rights and Credits of the Said Richard Duskey towards Satisfying unto the Said John Burnall as well the sum of twelve hundred and fifty pounds of Tobacco as also all Costs accruing upon the writ of attachment afo^r: and that the said John Burnall have the afo^r: of his Execution against the said Moses Duskey &c
