

Cometh and maketh Return thereof to the Court here Endorsed viz. To the Justice within mentioned And by vertue of the within writ to me directed I certify that I have attached as the Goods and Chattell, of the within named John Harristoy, in the hands of John Horsey Junr. to the Value of Seventy two pounds and Six pence Current money of Maryland and Eighteen hundred pounds of tobacco, and by William Handy and Littleton Townsend Good and Lawfull men of my Baywick I have made known unto the said John Horsey that he be and appear at the time and place within contained before the Justice within mentioned to show &c. as by the within precept I am Comanded --- Joshua Edwell ---  
 Whereupon the said John Horsey Gentleman of the aforesaid John Harristoy altho' Solamly called came not but made default &c.

Thereupon the said Hannah Waldron by her attorney aforesaid prays that upon Giving Security according to act of assembly in such case made and provided the aforesaid Sum of Seventy two pounds <sup>and Six pence</sup> Current money of Maryland and Eighteen hundred pounds of tobacco so as aforesaid attached in the hands of the aforesaid John Horsey may be condemned as of the goods and Chattell of the said John Harristoy towards Satisfying unto the said Hannah Waldron the Sum of Seventy two pounds <sup>& Six pence</sup> Current money of Maryland and Eighteen hundred pounds of tobacco, as also all costs accruing upon the writ of attachment aforesaid &c. ---

Thereupon certain Nathaniel Horsey of Somerset County Gent present heron Court undertakes for the said Hannah Waldron that if in case the said John Harristoy do at any time within a year and aday appear and make all or any part of the said Hannah Waldrons Claim against him appear to be Satisfied or otherwise to have been undue before the Laying of this attachment that then the said Hannah Waldron shall make Restitution unto him the said John Harristoy of all or such part thereof as shall be made appear to be undue &c. or that he the said Nathaniel Horsey will do it for her &c. ---

Therefore it is Considered by the Justice here that the aforesaid Sum of Seventy two <sup>and Six pence</sup> Current money of Maryland and Eighteen hundred pounds of tobacco so as aforesaid attached be condemned in the hands of the said John Horsey Junr. as of the Rights and Credits of the said John Harristoy towards Satisfying unto the said Hannah Waldron <sup>and</sup> as aforesaid as well the Sum aforesaid attached as also all costs accruing upon the writ of attachment aforesaid and that the said Hannah have thereof her 2/3 of the said John Horsey according to act of assembly &c. ---
