One thousand Seven hundred and thirty at Somerset County aforesaid within the Jurisdiction of this Court was indebted unto the said John in five pounds ten Shillings Current Money of Maryland as by a certain Note by the said Eliz: Signed and herunto annexed may in Court appear and being so thereof indebted the said Eliz: in Consideration thereof the day and Year aforesaid at Somerset County and within the Jurisdiction aforesaid upon herself did assume and to the said John then and there did faithfully promise that she the said Eliz: the said five pounds ten Shillings to the said John when she should be there unto Requested she would well and faithfully pay and Content Never the less the said Elizabeth her promise and Assumption aforesaid in some aforesaid made Nothing Regarding but Plotting and fraudulently Intending the said John in that part Casually and Subtly to Deceive and Defraud the said five pounds ten Shillings to the said John altho' the same to do the said Elizabeth by the aforesaid John on the aforesaid thirteenth Day of Decemb: in the Year aforesaid and often afterwards at Somerset County and within the said County he was there unto Requested hath not paid or to him for the same in any Sort Contented but the same to him hitherto to pay or in any Sort to Content hath refused and still doth Refuse and deny Whereupon he saith he is worse and hath Damage to the Value of Eleven pounds Money and thereupon he brings Suit &c.

One thousand Seven hundred and thirty One came again as well the said John Dennis by his attorney as the said Elizabeth Townsend in her proper person in Custody as aforesaid and whereupon further day is given to the said Elizabeth in Custody as aforesaid by the Court here until the next Court and the same day is given to the said plaintiff here also &c.
