 them concerning the same, and do not depart the same Court without License thereof &c.

 his Security, both present here in Court acknowledged themselves to be indebted unto his said Lord  
 ship the Right Honble the Lord Proprietary in forty pounds Sterling each, of their Goods  
 and Chattells Lands and tenements severally to be made and Levied to the Use of his said  
 Lordship his heirs and Successors &c. In case the said Joshua Merrill do not make his personall  
 appearance before the Justices of the next provinciale Court to be hold at the City of Annapolis  
 the third Tuesday of Aprill next, and do not then and there Give such evidence as he shall  
 know against the said Francis Laughlin and Mary Holio of and concerning such matters as they  
 stand charged with, and do not depart the same Court without License thereof &c. Likewise.
