

Deposant told Geo. Woolford it looked more proper to be hier up the Glade Capt. John Jones being present he said he thought so too ----- John Bozman. -----

Geo. Bozman Junr. aged about thirty five years being sworn he saith that Capt. John Jones told him that Mr. James Woolford was walking with him and several others and James Woolford told him the said Jones that some standing on a bank by the westernmost side of a marsh was the division between his brother Roger and Lewis Woolford, and John Bozman heeded and told him that, the other standing in the head of the Glade was more like to be the boulder than that on the bank and Capt. Jones said that he thought so too and further saith not

at Golden Quarter... } John Laws aged about fifty six years being sworn he saith that about seven years ago he heard old John Winsor say that a stump standing in the marsh a little to the westward of a gutt spring out of the thoroughfare a little distance from a small piece of hammock was a boulder of old Roger Woolford's Land, of what patent the Deposant knew not but he heard him talk several times since of that boulder (a gutt near where this boulder is, is in John Miller's pasture)

6th 16th 1751: Thomas Laws aged about forty two years being sworn saith that John Winsor said about seven or eight years ago told him that formerly he saw a boulder of Land cut down & that he (the said Winsor) told Roger Woolford said that there was a boulder cut down and Mr. Woolford seemed to be angry and told him it was a boulder of his Land the said boulder stood in the marsh near the thoroughfare a little distance from a hammock of pieces near the mouth of a gutt called Georges gutt about two hundred yards from standing called the Upper Landing in the thoroughfare and that the said piece was reckoned by the neighbours to be the outside boulder of Woolford's Land and further saith not ----- Thomas Laws -----

6th 7th 1751 }
John Winsor aged sixty one years the twenty ninth day of this Instant deposed and saith that about forty five years ago he lived on the Land now called Georges and one night to the best of his knowledge there was a marked piece cut down that stood by a small gutt at which he was concerned and some time after he told old Mr. Woolford of it and he said and being a common word with him and seemed to be angry and said that was his marked tree and the east boulder of the Land that Roger Shibly lived on and this Deposant well remembers it, a marked tree four notches on a side standing near Georges gutt on that side where Roger Shibly lived and further saith not ----- John Winsor -----

at manodeni -- } John Miller aged about fifty seven years or there about being sworn and saith that for about thirty years past he was well acquainted with the plantation of Roger Woolford's Land and that he always heard the gutt that divides the Land of said Woolford and Mr. Alexander Brown that runs up by John Woolford's house called the great pasture gutt and that he carried up abeck in a canoe and Oysters several times to
