whole jointly and severally finally by these presents sealed with our Seal and dated this 2th day of March
anno: Dow. 1731.

The condition of the above obligation is such that whosoever the Comiffary General
shall Transmitted into this Court the amount of the whole of Lodowick Glennan dec^d wherein it is found that there is
balance due to the above said orphans the sum of Sixty five pounds and Seven Shillings current money if therefore the
above said John Lay his Executors or administrators shall and do well and truly pay or cause to be paid unto the above
named Lavinia Glennan the aforsaid sum of Sixty five pounds and Seven Shillings current money according to out of
a publicly and o'ded. will then the said shall arrive at full age to receive the same &c. then the above obligation to be void &
of none effect otherwise to remaine in full force & virtue until then
sealed and del^d in the presence of
