able to do any manner of Busines since your petitioner had the hind fortune to ^{buy} the said Slave therefore -
Your petitioner pray that your worshipps will be pleased to Consider your petitioner and to let your petition
Negro tax free and in so doing your petitioner is in duty bound forever foray Tho Selby

The petition aforesaid being Read and heard - Wherefore it is Considered that the aforesaid Thomas
Selby bedischarged from paying of taxes for the aforesaid Negro for the future, as by the petition aforesaid
is placed &c
