Wherefore it is considered by the Justices here that the aforesaid Elizth Leacocke be whipt at the publick whipping post with twenty Lashes on the bare back well Laid on untill the blood appear, and as to the Corporall punishment aforesaid Command is given to the Just. of Somerset County that he do there of Immediate Execution by whipping of the said Elizth Leacocke at the publick whipping post with twenty Lashes on the bare back well Laid on untill the blood appear, and that she be taken &c. and afterward in the same Court came the said Just. and makes return that he had done the Execution of the Judgment aforesaid as to the Corporall punishment aforesaid he was commanded whereupon the aforesaid Elizth Leacocke is ordered to give Security for the payment of the severall Officers their fees due by occasion of the premises afo but for want thereof the said Elizth Leacocke is committed into the Custody of the Just. of Somerset County there to remain &c. the said Just. to witt Joseph Caldwell present took Charge of the said Elizth Leacocke accordingly &c.

Thereupon Command was given to the Just. of Somerset County that he should take the said Benjamin Gasque of Co. to answer &c. --- and afterward in the same Court came the said Benjamin Gasque in his proper person, and says that he cannot deny but that he is guilty of the premises above upon him imposed in manner & form above Complaind and is willing to pay his fine for the fact aforesaid - Wherefore it is considered by the Justices here that the aforesaid Benjamin Gasque pay unto his Lordship for his fine by the Court laid upon him imposed for and by occasion of the premises afo whereof in form aforesaid he is convicted thirty shillings Court Money to the Use of the County afo and that he be taken &c. whereupon the said Benjamin Gasque is ordered to give Security for payment of the severall Officers their fees due by occasion of the premises afo but for want thereof the said Benj: Gasque is committed into the Custody of the said Just. there to remain &c. the said Just. to witt Joseph Caldwell present took Charge of him accordingly
